Mr. Goodson updated the CDE Board Members on the following 2013 NMTC progress:

- Two NMTC-financed projects were completed in 2013:
 - o Hampton Inn & Suites (\$17MM)
 - o Americana YMCA (\$11.1MM)
- Two NMTC-financed projects are in progress and are scheduled to open in 2014:
 - o Emerge Center (Speech and Hearing Foundation)
 - o Honeywell (\$34 M)
- EBRCDE has submitted its 2013 NMTC application. The total amount of allocation requested was \$75.46 million. Awards will be announced in April/May 2014.
- Reporting for the completed NMTC projects will start in March 2014.
