DISCUSSION	Mr. Tyson presented the YTD Profit and Loss Actual vs. Budget, Program Statement of Activity and Monthly Cash Flow Projections for the period ended May 31, 2021. BBR will seek reimbursement of approximately from the City Parish for federal grants administration as soon as the contract amendments are approved by the City Parish for the Entitlement and CARES Act funding.		

	LINCOLN TRAILS PROJECT UPDATE	TARA TITONE	
DISCUSSION	Ms. Titone asked the board to consider adoption of a resolution to approve the filing of an application for grant funds from the FHWA Recreational Trails Program for Louisiana, and authorize the President & CEO to conduct all negotiations necessary for the sponsorship and completion of the project. BBR will work with the Louisiana Black History Hall of Fame to submit an application for \$100,000 to complete sidewalk and phase II urban trail enhancements along Myrtle Street that will connect Lincoln Theater to Expressway Park and Park Blvd. The funding awards will be made in 2022.

	BUILD BATON ROUGE CEO PRESENTATION	CHRISTOPHER TYSON	
DISCUSSION	Administration Mr. Tyson welcomed new hires Gretchen Siemers, Cornelius Payne and Leonard Briscoe. BBR's audit consultant has submitted a draft of BBR's 2020 financials. The audit finalization is partially held up by the City Parish's CEA processing for the HUD grant that BBR administers. BBR has apprised the city of the pressing matter. BBR's 2022 budget request is due on Jan. 25 to the City-Parish. Mr. Tyson reported he expects the allocation to be around the same allocation as in 2021 and will be sharing more information about the budget projects. BBR has experienced a few staff departures and is in a season of transition. Marla Morris, at BBR since 2018 as the Grants Fiscal Manager, departed BBR on June 11 but will be staying on to assist as consultant for the next several weeks; Matthew Johnson, BBR's Staff Attorney, has accepted a law firm job in New Orleans where he resides. His last day is Friday; Tasha Saunders, BBR Grants Director, will become the new Urban Development Director at the City-Parish on June 21 and will continue to be in communication with BBR regarding the administration of the HUD grants.		
	Real Estate and Land Bank BBR has identified two parcels on Plank and Erie St. that are adjudicated with the City-Parish. BBR met with Councilwoman Coleman. The item will be introduced for transfer into BBR's land bank at next week's Council meeting.

Ardendale

The EBR Housing Authority is planning to purchase 23 acres for housing development as part of the BRChoice HUD Choice Neighborhoods Grant. The plans are in-line with the HUD CNI plan submittal. BBR and The Housing Authority have been working with the City on the Lobdell-Ardenwood connector road and the location has been set. BBR has additional property at the northeast intersection outside of the wetlands footprint at Ardendale and is working on the determining the size of a developable footprint.

DISCUSSION

Electric Depot

Electric Depot continues to pay rent on time and Red Stick Social is reopening for events. No additional updates. BBR continues to work towards the purchase of S. 14th property which is now under contract. The purchase of this property will assist in facilitating development as recommended in teh Rail Station Master Plan.

Projects

- JPMorgan Chase Advancing Cities Grant/ Plank Road Master Plan: The New Markets Tax Credits closing is still in-progress and wrap-up is targeted for July. All entities have confirmed reservation letters and all partners are at the table. Weekly coordination calls continue.
- Florida blvd Economic Development District (EDD)- The drafting of the CEA is underway with the Parish Attorney. BRAC and the mayor are partnering with BBR on this efforts. Mr Braxton asked when the item will be introduced to the Metro Council. Mr. Tyson stated that the item is projected to go before Council in late July and that two additional members from the district would join the EDD board in addition to BBR board members.
